

ADDENDUM I - 2020

ADDENDUM NUMBER 1 TO AGREEMENT BETWEEN THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS AND CEASEFIRE AND TRANSITIONAL SECURITY ARRANGEMENTS MONITORING AND VERIFICATION MECHANISM (CTSAMVM) CONCERNING ADDITIONAL FINANCIAL SUPPORT TO CTSAMVM, SSD-19/0004 – SUPPORT TO CTSAMVM.

1 BACKGROUND

- 1.1 The Norwegian Ministry of Foreign Affairs (MFA) and the Grant Recipient (jointly referred to as the Parties) have entered into an agreement dated **15 October 2019** (the Agreement) concerning SSD-19/0004 – Support to CTSAMVM (the Project).
- 1.2 The Grant Recipient has submitted a request to MFA dated 24 March 2020 – with revised version dated **16 April 2020** regarding additional financial support to the Project, and extension of the Support Period to **31 December 2020** with which MFA has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number 1 (the Addendum), which shall be an integrated part of the Agreement.

2 EXTENSION OF THE SUPPORT PERIOD

- 2.1 The Support Period set forth in the Agreement shall hereby be extended to 31 December 2020

3 ADDITIONAL GRANT

- 3.1 MFA shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement and this Addendum, provide an additional grant not exceeding **NOK 14 000 000** (Norwegian Kroner Fourteen Million) (the Additional Grant).
- 3.2 The Additional Grant shall be used exclusively to finance the Project as specified in the budget attached as Annex A to this Addendum, and in the Application during the Support Period.
- 3.3 The Additional Grant shall be disbursed semi-annually and upon written request as described in the Agreement.

4 ADDITIONAL AND REVISED CONDITIONS

Reporting period shall hereby be extended as follows;

- 4.1 The Parties shall hold one formal meeting as per clause 8 of the Agreement tentatively in September 2020, and MFA shall be invited to participate in all CTSAMVM's planned meetings. The Parties may hold other formal meetings if/when requested by MFA. At least one common donor meeting should be held during the support period. Details regarding agenda and procedures will be agreed upon by the Parties.
- 4.2 Audit Report shall be as per clause 7 of the Agreement and shall be submitted to MFA by 31 March 2021.
- 4.3 Final report with aggregated data for both 2019 and 2020 shall be submitted to MFA by 31 March 2021.

5 REMAINING CONDITIONS OF THE AGREEMENT

- 5.1 All other provisions of the Agreement shall remain unchanged and in force.

6 ENTRY INTO FORCE AND DURATION

- 6.1 The Addendum shall enter into force on the date of the last signature, and remain in force until all obligations arising from it have been fulfilled.

This Addendum has been signed in two -2- original copies in the English language, whereof the Parties keep one each. In the event of any discrepancies between this English language version and any later translations, the English language version shall prevail.

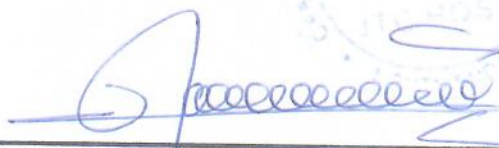
