ADDENDUM NUMBER 7 TO AGREEMENT BETWEEN THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS AND CEASEFIRE AND TRANSITIONAL SECURITY ARRANGEMENT MONITORING AND VERIFICATION MECHANISM (CTSAMVM) CONCERNING SUPPORT TO CTSAMVM, SSD-19/0004.

1 BACKGROUND

- 1.1 The Norwegian Ministry of Foreign Affairs (the Donor) and Ceasefire and Transitional Security Arrangement Monitoring and Verification Mechanism (CTSAMVM) (the Grant Recipient) (jointly referred to as the Parties) have entered into an agreement dated 15 October 2019 (the Agreement) as amended by addendum number 1 dated 30 May 2020, addendum number 2 dated 21 June 2021, addendum number 3 dated 19 May 2022, addendum number 4 dated 22 June 2023, addendum number 5 dated 3 July 2024, and addendum number 6 dated 20 June 2025 concerning SSD-19/0004--Support to CTSAMVM (the Project).
- 1.2 The Grant Recipient has submitted an application for continuation of the project to the Donor dated 28 April 2026 regarding additional financial support to the Project, and extension of the Support Period, with which the Donor has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number 7 (the Addendum), which shall be an integrated part of the Agreement.

2 EXTENSION OF THE SUPPORT PERIOD

- 2.1 The Support Period set forth in the Agreement shall hereby be extended from 1 April 2026 to 28 February 2027.

3 ADDITIONAL GRANT

- 3.1 The Donor shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, including previous addenda, and this Addendum, provide an additional grant not exceeding NOK 11,055,000 (Norwegian Kroner eleven million and fifty-five thousand) (the Additional Grant).
- 3.2 The Additional Grant shall be used exclusively to finance the Project in accordance with the Application. A revised Agreement budget (Annex A) which includes the Additional Grant is attached to this Addendum.
- 3.3 The Additional Grant shall be disbursed in three tranches. The first tranche of NOK 3,685,000 shall be disbursed upon the signing of this Addendum. The second tranche of NOK 3,685,000 shall be disbursed in September 2026, and the final tranche of NOK 3,685,000 shall be disbursed in December 2026, subject to the receipt of a written disbursement request demonstrating the financial need for the funds.

4 ADDITIONAL CONDITIONS

- 4.1 The expected results as described in Article 2.1 and 2.2 of the Agreement are revised to include the updated results framework attached as Annex B to this addendum.
- 4.2 If any of the mechanisms supporting the peace agreement, or the Peace Agreement itself, ceases to exist or substantial changes are made, then the need for supporting the CTSAMVM will also cease to exist and the Agreement between CTSAMVM and the Embassy will discontinue with the provisions on termination of agreement followed.

5 REMAINING CONDITIONS

- 5.1 All other provisions of the Agreement shall remain unchanged and in force.

6 ENTRY INTO FORCE AND DURATION

- 6.1 The Addendum shall enter into force on the date of the last signature and remain in force until all obligations arising from it have been fulfilled.

This Addendum has been signed by both Parties. In the event of any discrepancies between this English language version and any later translations, the English language version shall prevail.
